

# Subscription Instructions

The subscription service was created to give districts the ability to subscribe and unsubscribe to specific New York State Office of Temporary and Disability Assistance, Employment and Income Support Programs (EISP) mailings on their own and should help eliminate receipt of duplicate copies.

## Subscription Screen

The table below lists the various subscription items. Simply select the type of correspondence that you wish to receive and click on the link to either subscribe or unsubscribe. A mail message will appear, simply click on the send button. Your e-mail address will automatically be sent to the list you requested. Once your request to be added to a particular list is received, you will get a welcome notice.

***NOTE: You must subscribe to each list separately. The service can NOT subscribe you to multiple lists at one time.***
