Homeless Housing and Assistance Program (HHAP)

- RFP released May 25, 2023
- Suspended acceptance of applications on July 25, 2024
- SFY 2024-25: 32 applications received requesting over \$261 million
 - 16 projects awarded, totaling \$131 million in funding
 - Will create or preserve 840 units of housing
- SFY 2023-24: 32 applications received requesting over \$175 million
 - 20 projects awarded, totaling \$126 million in funding
 - Creating or preserving 735 units of housing

HHAP (continued)

- Outcomes:
 - 100 projects in development
 - 49 currently in construction
- Operations:
 - 388 operational projects including 820 buildings and 13,602 units
 - Project Based Vouchers (PBVs) via HCR
 - Awarded 47 PBVs for two projects; one in Suffolk County, one in Fulton County

Empire State Supportive Housing Initiative (ESSHI)

- Round 9 RFP release date TBD
- Round 8 RFP released October 10, 2023
 - 139 applications received; 122 conditional awards
- OTDA Contract Outcomes:
 - 2,962 units locked-in to date
 - Over \$40 million claimed as of August 1, 2024

Housing Opportunities for Persons with AIDS (HOPWA)

- RFP released July 20, 2023
 - Applications – 13
 - Awards – 13
 - Allocation – \$3.8 million
- Number of HOPWA Households Receiving Subsidies:
 - 2023: 362 households
 - 2022: 349 households
 - 2021: 318 households

New York State Supportive Housing Program (NYSSHP)

- Contracts end December 31, 2026
- New RFP anticipated Summer 2026
- SFY 2024-25: 134 contracts and \$45,425,443 in total funding
- Outcomes (SFY 2024-25):
 - 20,320 units in total
 - 17,438 single adult units
 - 2,510 family units
 - 372 young adult units
- SFY 2024-25: funding formula increase as of January 1, 2024
 - \$247 per bed per month for single and young adult units
 - \$325 per unit per month for family units

Operational Support for AIDS Housing (OSAH)

- RFP Released February 17, 2023
 - Awards: 6
 - Appropriation: \$1,080,000
- Outcomes:
 - 25 units for families
 - 85 units for singles

Emergency Needs for the Homeless Program (ENHP)

- RFP Released April 5, 2023
 - Awards: 3
 - Appropriation: \$1 million
- Outcomes:
 - Over 300,000 meals served through emergency food services
 - Over 7,600 individuals received crisis intervention services
 - Over 1,900 households received eviction prevention services
 - Over 7,100 children received summer youth programming

Emergency Solutions Grant COVID (ESG-CV)

- Awards – 55 for the period October 1, 2020 – September 30, 2023
- Appropriation – \$56.1 million, including outreach funds for the Emergency Rental Assist Program (ERAP)
- Outcomes for the three-year period:
 - More than 40,900 persons served
 - 29 providers assisted with Street Outreach Services
 - 85 providers assisted with Emergency Shelter
 - 72 providers assisted with Rapid Rehousing
 - 85 providers assisted with Eviction Prevention
- 100% of HUD funds were spent. Thank you, ESG-CV contractors!



Solutions to End Homelessness Program (STEHP)

- Appropriation – uses a combination of State and Federal ESG funds for a total of \$19.7M annually.
- 66 current contracts ended September 30, 2024. OTDA plans to pursue No Cost Time Extensions for those not receiving a new contract or for those not fully funded.
- RFP was released April 12, 2024. 92 applications were received with a total request of \$30 million. OTDA is making 76 awards.
- The RFP recognized the need for more funds dedicated to homeless services. More reliance on the Legal Services for Eviction Prevention Program.

Legal Services for Eviction Prevention/ Housing Stability

- Awards – 8
- Appropriation – \$50 million
 - \$40 million outside of NYC
 - \$10 million to NYC
- Outcomes:
 - Over 19,000 households served

New York State Balance of State Continuum of Care (BoS CoC)

- BoS coverage area: Cattaraugus, Clinton, Fulton, Herkimer, Montgomery, Putnam, Schoharie and Sullivan Counties
- Operating two RRH programs targeting rural and unsheltered homelessness totaling \$2,503,302
- New CoC Funding FY2023 – \$399,992
- Warming Center operational or in development in each county
- Several HHAP/ESSHI projects in development
- Custom reporting from HMIS data is available upon request

Challenges

- **Construction and Development:**

- Material and labor shortages
- Increased insurance costs

- Increased lead time on materials
- Increased material costs

- **Operations:**

- Overstretched staff
- Increase insurance
- Occupancy rates

- Decreased revenue
- Limited housing stock
- Property Management Relations

- **Services:**

- Staffing shortages
- Lack of affordable units

- Damaged landlord-tenant relationships
- Health/safety-minded case management
